I am directed to state that the Board of Governors considered the Assessment Report (13.07.2020) on the standard of examination and other teaching facilities available at Gujarat Adani Institute of Medical Sciences, Bhuj for purpose of Recognition of MS(General Surgery) qualification for 04 seats granted by KSKV Kachchh University, Bhuj and decided as under:-

"The Board of Governors considered the Council Assessor's Report (13.07.2020) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MS(General Surgery) qualification for 04 seats granted by KSKV Kachchh University, Bhuj in respect of students being trained at Gujarat Adani Institute of Medical Sciences, Bhuj be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
